






#### Dimensions (Unit : mm)




#### **Derating Curve**




### Switching Frequency

#### Operation Notes

- An excessively large capacitance at C1 may cause the output to become inactive. Therefore, a capacitance between 1000 and 2200µF is recommended, with a rise time of 10ms or
- The capacitance of C3 should be 10µF, since an excessively small value will result in malfunction. The activation time is defined as: t(sec)=R2 C3 In[1-17/(VI-30µA R2)], where VI is the DC voltage after smoothing.
- The resistance of R2 should be 1.5MΩ, since an excessively small value will result in malfunction.
- Overcurrent (reset type) and overvoltage (latch type) protection circuits are built in, preventing damage from occurring due to unexpected conditions. The overvoltage protection circuit shuts down operation once V<sub>bb</sub> exceeds 20V. In order to reset the input capacitor C4 must be discharged and the power turned back on.
