











# MAXIMUM NON-REPETITIVE FORWARD SURGE CURRENT




### TYPICAL REVERSE CHARACTERISTICS




# TYPICAL INSTANTANEOUS FORWARD CHARACTERISTICS PER LEG




#### TYPICAL JUNCTION CAPACITANCE
