1.1 General description

Dual high-speed switching diode, encapsulated in a very small SOT323 (SC-70) Surface-Mounted Device (SMD) plastic package.






- (1) $T_i = 150 \,^{\circ}\text{C}$; typical values

Fig 1. Forward current as a function of forward voltage




 $f = 1 \text{ MHz}; T_{amb} = 25 \,^{\circ}\text{C}$

FR4 PCB, standard footprint


- (1) single diode loaded




Fig 6. Forward recovery voltage test circuit and waveforms


