Description

The CPC1231N is a miniature single-pole, normally closed (1-Form-B) solid state relay in a 4-pin SOP package that employs optically coupled MOSFET technology to provide 1500V_{rms} of input-to-output isolation, and is compliant with supplementary isolation in accordance with EN/IEC 60950-1. The efficient MOSFET switches and photovoltaic die use Clare's patented OptoMOS® architecture while the optically coupled output is controlled by a highly efficient GaAlAs infrared LED.

Clare's state of the art double molded vertical construction packaging enables the CPC1231N to be one of the world's smallest 4-pin relays, which offers board space savings approaching 20% over the competitor's larger 4-pin SOP relay.

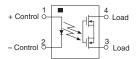

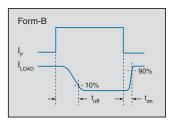

Moisture Sensitivity

Board Wash

Clare recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since Clare employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.

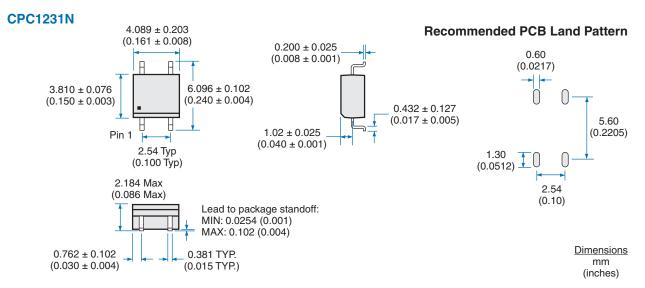




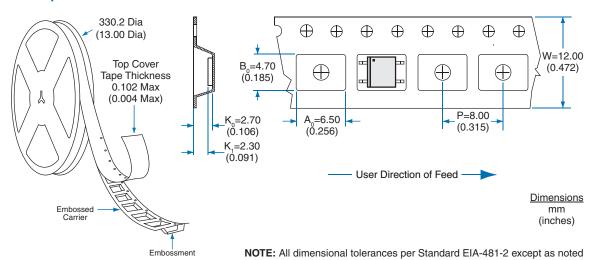
