


 $V_{\mbox{\scriptsize DS}}$ - Drain-to-Source Voltage (V)






On-Resistance vs. Drain Current




V_{GS} - Gate-to-Source Voltage (V)




On-Resistance vs. Junction Temperature








Source-Drain Diode Forward Voltage






On-Resistance vs. Gate-to-Source Voltage



Single Pulse Power, Junction-to-Ambient





Safe Operating Area, Junction-to-Ambient







Normalized Thermal Transient Impedance, Junction-to-Case (Drain Top)




Normalized Thermal Transient Impedance, Junction-to-Source


